HD 33

- Katrina Pierson (R)
 - No grade
 - No campaign discussion of transportation.

HD70

- Mihaela Plesa (D)
 - Grade of **A**
 - Stated support of DART and public transportation.

- Steve Kinard (R)
 - No grade
 - No campaign discussion of transportation

HD 112

- Averie Bishop (D)
 - Grade of A
 - Opposed House Bill 2392 (2019) to expand Texas' electric vehicle infrastructure, argues it would impede more efficient and greener public transportation.
 - Proposes solution of advocating for holistic urban planning, prioritizing walkability, green spaces, and public transportation.
 - Stated she uses the DART system to get to work (needs citation?)
- Angie Chen Button (R)
 - No grade
 - No campaign discussion of transportation

HD 115

- Cassandra Hernandez (D)
 - Grade A
 - Does not support DART cuts ordered by the state, believes that the DART board should have control over the budget.
 - Would like to see TXDoT divert more funds to mass transit projects. Believes to combat climate change and improve public safety, transit should be moved from cars to trains and buses.

HD103

- Rafael Anchia (D)
 - No grade.
 - Campaign website does not mention transportation, no bills were public transport related.

HD98

- Scott Bryan White (D)
 - Grade of A
 - Campaign website states support of high-speed trains connecting Texas' major and minor cities. Has stated support of public transportation.
- Giovanni Capriglione (R)
 - No grade.
 - Campaign website does not mention transportation.

SD8

- Rachel Mello (D)
 - Grade of A

- Does not support a reduction or cap on DART's sales tax levy, would be open to an increase in the sales tax cities are capable of levying given a vote of the city's constituents is in approval.

SD12

 - Grade of A
 - Stated opposition to DART cuts, believes in the importance of public transport.

 - Stated support of DART on social media platforms, has worked with DART staff to discuss future legislation.
